SOCIAL MEDIA POLICY & GUIDELINES

As a member of the **GOLD COAST DERBY GRRLS**, **LLC (GCDG)** you have the responsibility to portray your team and yourselves in a positive manner at all times.

Facebook, Twitter and other social media sites have increased in popularity globally, and are used by the majority of Roller Derby teams worldwide to promote and market their leagues. **GOLD COAST DERBY GRRLS** members should be aware that third parties could easily access your profiles and view all personal information. This includes all pictures, videos, comments and posters. It is important for members to understand that the Gold Coast Derby Grrls, LLC is a business and in order for us to be successful, we must present ourselves as such. Inappropriate material found by third parties (i.e. sponsors, vendors, etc.) affects the perception of the league and can possibly hinder us from securing profitable partnerships.

In addition, **GOLD COAST DERBY GRRLS** also respects the right of its members to express their views publicly. At the same time, we must be aware of the dangers social media and networking can present to our public persona. Use your best judgment at all times – pause before posting. Once your comments are posted, they cannot be retracted. Ultimately, you are solely responsible for your comments and they are published for the public record.

Examples of inappropriate and offensive behaviors may include depictions or presentations of the following:

- Photos, videos, and comments that are of a sexual nature.
- Pictures, videos, comments or posters that condone drug-related activity.
- Any statement deemed to be publicly critical of League officials or detrimental to the welfare of a member, or the League
- Refrain from divulging confidential information of a personal or team related nature. Avoid revealing business or game strategy that could provide another team or individual a competitive advantage. Furthermore, do not discuss injury information about any player. Only divulge information that is considered public.
- Content online that is unsportsmanlike, derogatory, demeaning or threatening toward any other individual or team (examples: derogatory comments regarding another institution; taunting comments aimed at a skater, coach or another team and derogatory comments against race and/or gender).
- No posts should depict or encourage unacceptable, violent or illegal activities (examples: hazing, sexual harassment/assault, discrimination, fighting, vandalism, underage drinking, illegal drug use).
- Content online that would constitute a violation of WFTDA rules.
- Linking to any Gold Coast Derby Grrls media through any type of social media sites (i.e. Facebook allows you to link by posting a place you have worked, or do work at) and have any unethical type of post that will reflect poorly on the league.

If a **GOLD COAST DERBY GRRLS** member profile and its contents are found to be inappropriate in accordance with the above behaviors, the member will be subject to the following penalties:

- 1. First Offence Written warning with a chance to correct the inappropriate content.
- 2. Second Offence Penalties as determined by the officers of the Gold Coast Derby Grrls, including but not limited to possible suspension and/or expulsion from the league.

If you are ever in doubt of the appropriateness of your online public material, consider whether it upholds and positively reflects your own values and ethics, as well as the business model for the Gold Coast Derby Grrls, LLC
